4. First Aid Measures

Emergency and First Aid Procedures:

- In Case of Inhalation:** Remove from exposure and move to fresh air immediately. If breathing is difficult, give oxygen. Get medical aid immediately.
- In Case of Skin Contact:** Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse. In case of contact, flush skin with plenty of water. Remove contaminated clothing and shoes. Get medical aid if irritation develops and persists.
- In Case of Eye Contact:** Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.
- In Case of Ingestion:** Never give anything by mouth to an unconscious person. Get medical aid. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water. Call a poison control center. Potential for aspiration if swallowed. If vomiting occurs naturally, have victim lean forward.

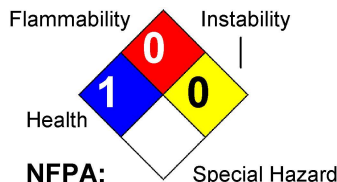
